From Tappan she rode horseback to the Hudson River, crossed in a row boat and picked up the papers in New York City. Returning, she retraced her path and delivered the correspondence to the General.

Anna Elizabeth (Brouwer) Quackenbosch was a great-granddaughter of the famed Anneke Jans Bogardus. Anneke was an early settler of New York City and owned a farm in what was to become the financial center of Manhattan. In the latter part of the 1600's, Anneke's farmland was leased out on a 99 year lease. At the end of the first 99 years, the lease was extended for a second term. At the expiration of this second term, however, the land was not returned to Anneke's heirs. In the mid-1800's, various descendants of Anneke Jans joined together to pursue their legal claim to this land, by then already worth millions of dollars. Various "Descendants' Associations" were formed to finance the prosecution of these claims and to establish rights of inheritance for the eventual distribution of the legal settlements.

The Quackenbush family was quickly brought into these lawsuits because Anna Elizabeth Brouwer married Jacob Quackenbosch. Although only a portion of the Quackenbush family is descended from Jacob and Anna Elizabeth (Brouwer) Quackenbosch, Quackenbush families were contacted indiscriminately in the late 1800's and assured that they were entitled to share in the Anneke Jans estates. Most were asked to submit family records to the staff genealogists, which were then carelessly (and sometimes fraudulently) tied back to Anneke.

As the Descendants' Associations grew, so did the myth of Anneke Jans. The Associations began claiming that Anneke Jans was a granddaughter (though not legitimate) of the King of Holland and therefore was entitled to part of the estates of the Dutch royal family. Based on such unfounded claims, the Associations grew faster and faster until, finally, their suits were heard by the courts. One by one these suits were thrown out, and to this day, not one case has been decided in favor of the descendants. Many of these pedigrees are still to be found today, and despite the incorrect connections in the early generations, have helped to preserve many family records from the late 1700's through the early 1900's.
