After Andrew married in 1863, he and his bride lived on part of Lot 4 of the Fourteenth Concession of Seymour Township. In 1866, his brother Rinard was living on the same property, but by 1869, Andrew had moved to the north half of Lot 4 of the Twelfth Concession. On 15 Nov. 1871, Andrew, an unmarried man (his first wife had just died), took out a mortgage on the above property. He actually purchased it on 16 Jan. 1872. On 6 Dec. 1878, Andrew sold the property and moved to Lot 8 of the Seventh Concession of Belmont Township, Peterborough County. In 1891, the family was living in a five room, one and one half storey wood house. The family was Methodist. Andrew, his two wives and infant daughter, Annie Jane, are all buried in Old Polmont Cemetery on the Thirteenth Concession of Seymour Township.

In the census of 1861, Calvin was a tailor living with his older cousin, James Quackenbush of the firm of Lazier and Quackenbush in the town of Dundas, Ontario. He had returned to Prince Edward County by 1865, when he married Mary Cornrike. Following their marriage, the family lived in the village of Consecon in Hiller Township. Calvin bought the north half of village Lot 3 on the west side of Mill Street on 16 Nov. 1868. On 24 Mar. 1871, Calvin, listed as a tailor in the village of Brighton, sold his Consecon property. By the time of the 1881 census, Calvin, still listed as a tailor, had moved back to Prince Edward County and was residing in Sophiasburgh Township. In the 1891 census, Calvin and his family had moved again, to Perry Township, Northumberland County, where they lived in a twelve room, two storey wood house. In 1906, the family was living in Warkworth on Lot 16 of the third Concession of Percy Township. The family was Methodist. The eldest son, James, was named after Calvin's cousin, with whom Calvin learned to be a tailor. James had died shortly after Calvin left Dundas.

Rinard was living with his brother Andrew, a farmer, on the east half of Lot 4, Fourteenth Concession of Seymour Township, Northumberland County, Ontario, in 1866. Shortly afterward, Rinard moved to the United States, probably directly to Michigan. In the 1900 census Rinard stated that he had immigrated to the U.S. in 1868. It is possible that Rinard's decision to move to the U.S. was prompted by the arrest of his father's first cousin, also named Rinard, for counterfeiting in the spring of 1866. In the census of 1880, Rinard was living in Grand Rapids, Ml. Under occupation, he was listed as "on street car," so presumably he was a motorman or conductor. In the censuses of 1900 and 1910, still in Grand Rapids, he was listed as a lumber inspector.
